1. **Terms of sale are cash. The extension of credit is conditional upon acceptance by Newmarket Auto Parts Group Inc. O/A Barrie Auto Parts as notified in writing. Once credit is granted the terms are 2%, 15<sup>th</sup> net 30 days.**
2. **Finance charges are assessable on past due amounts as determined by the approved terms and conditions of sale. Presently the interest rate is 1.50 % per month compounded (19.56% annually) and is payable without dispute.**
3. **Any dispute, claim or return of goods from the purchase of products from Newmarket Auto Parts Group Inc. O/A Barrie Auto Parts must be in writing within 30 days of the date of invoice and must be accompanied by the invoice causing the claim.**
4. **If there is any change in the status of the Customer set forth in part A (ie change of business name or ownership) the Customer shall immediately notify Newmarket Auto Parts Group Inc. O/A Barrie Auto Parts. To the extent that the business is still being carried on by one or more of the same persons under a new name or legal status, the "new business" is jointly liable for sums already owed by the Customer, as well as sums owed on account of delivery of goods or services after the change of name or status.**
5. **I/We the undersigned, certify that all information given on this application is true, complete, and correct.**
6. **I, the undersigned authorize and consent to the receipt and exchange of any and all credit information Newmarket Auto Parts Group Inc. O/A Barrie Auto Parts, and I/we guarantee that all balances due will be paid in full.
